#### What data do we collect?

Dellusion Records collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Your address (if provided in your account settings)

### How do we collect your data?

You directly provide Dellusion Records with most of the data we collect. We collect data and process

#### data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

## How will we use your data?

Dellusion Records collects your data so that we can:

• Process your order, manage your account.

When Dellusion Records processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

# How do we store your data?

Dellusion Records securely stores your data at our highly secured data center managed by Amazon Web Services

Dellusion Records will keep your personal details for as long as your account is active, plus 3 months. Once this time period has expired, we will delete your data by an automated service, that will wipe your data from our servers

## What are your data protection rights?

Dellusion Records would like to make sure you are fully aware of all of your data protection rights.

Every user is entitled to the following:

- The right to access You have the right to request Dellusion Records for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification You have the right to request that Dellusion Records correct any information you believe is inaccurate. You also have the right to request Dellusion Records to complete information you believe is incomplete.
- The right to erasure You have the right to request that Dellusion Records erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that Dellusion Records restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Dellusion Records' processing of your personal data, under certain conditions.
- The right to data portability You have the right to request that Dellusion Records transfer the data that we have collected to another organization, or directly to you, under certain conditions.
